Following points may be kept in mind while proposing and seconding the names for election:

1. No individual shall hold the same post consecutively for more than one term as per Constitution of the Society.
2. For the post of General Secretary, Assistant secretary and Treasurer active members only from Head Quarters i.e. Division of Agricultural Chemicals, IARI, New Delhi will be eligible for contesting the election provided they are left with active service for the full term (three years) of 9<sup>th</sup> Executive Council.

3. Only the active members from respective zones will be eligible to contest the election for the position of Vice- Presidents and councilors. The following zones/chapters have been identified by Society with the states covered by each zone.
